### **MINUTES**

Of the Regular Meeting of The Claiborne Parish Police Jury December 10, 2014 Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the tenth day of December 2014. On being called to order by President, Scott Davidson, the following jurors were present:

WHEREAS, the Claiborne Parish Police Jury will be providing local funds up to \$10,000 to ensure completion of the awarded project;

BE IT RESOLVED, that the Claiborne Parish Police Jury does hereby approve and support this grant application and its purpose.

Resolution 2014-2019 – 2015 Authorizing Resolution for OOCS.

**Authorizing Resolution 2015** 

Resolution authorizing the filing of an application with the Louisiana Department of Transportation and Development for grants through the US DOT Federal Transit Administration (FTA), as authorized under Federal Transit Laws, as codified, 49 USC Section 5317, New

Freedom Program and executing with the Louisiana Department of Transportation and Development upon project approval.

WHEREAS, the Director of the Louisiana Department of Transportation and Development is authorized to make grants for a New Freedom projects;

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provisions by it of the local share of project costs in the program;

WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provisions of the Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under 49 USC Section 5317 the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964, and the U.S. Department of Transportation requirements thereunder, and

WHEREAS, it is the goal of the applicant that the disadvantaged business enterprise be used to the fullest extent possible in connection with this/these project(s), and that definite procedures shall be established and administered to ensure that disadvantaged businesses shall have the maximum construction contracts, supplies, equipment, or consultant and other services:

# NOW, THEREFORE, BE IT RESOLVED by Claiborne Parish Police Jury:

- 1. That the <u>Parish President</u> is authorized to execute and file an application(s) on behalf of <u>Claiborne Parish Police Jury</u> with the Louisiana Department of Transportation and Development, to aid in the financing of operating assistance projects pursuant to the New Freedom Program, USC 5317.
- 2. That the <u>Parish President</u> is authorized to execute and file with such applications and assurance or any other document required by the U.S. Department of Transportation and Development effectuating the purpose of the Title VI of the Civil Rights Act of 1964.
- 3. That the <u>Parish President</u> is authorized to furnish such additional information as the Louisiana Department of Transportation and the Development may require in connection with the application for the program of projects submitted to FTA.
- 4. That the <u>Parish President</u> is authorized to set forth and execute affirmative disadvantaged business policies in connection to any procurements made as part of the project.
- 5. That the <u>Parish President</u> is authorized to execute grant contract agreements on the behalf of <u>Claiborne Parish Police Jury</u> with the Louisiana Department of Transportation and Development for aid in the financing of operating assistance projects.

Robert McDaniel gave a brief update on the various building projects with the Claiborne Parish Police Jury. The New Hwy 2 Road Shop roof should be almost complete, the CID is in the process of renovations, the Admin Building is getting close to going out for bid on sealing the brick and roof work, and the Courthouse is in the process of a future roof replacement.

Upon motion by Joe Sturges, duly seconded by Mark Furlow, the Jury unanimously approved and authorized Superintendent Tommy Durrett, Secretary-Treasurer Dwayne Woodard, and Parish Attorney Danny Newell to begin the process of drawing up an agreement with Union

County Arkansas and the Claiborne Parish Police Jury to turn over the portion of West State Line Road to Union County Arkansas to bring back in the future for the Jury to review and then approve.

There were no recommendations from the Finance Committee.

President Scott Davidson read the Resolution from Claiborne Parish Hospital Service District #3, requesting that the Police Jury place a ½ cent parish wide sales tax proposition in support of CMMC on the March 28, 2015 ballot.

Upon motion by Joe Sturges, duly seconded by Robert McDaniel, the Jury approved the accept the resolution from CPHSD#3 by a vote of 7-3 (For - Stevens, Furlow, McDaniel, Sturges, Lewis, Adkins, Davidson) and 3 being against (Penix, Young and Mardis) requesting that the Claiborne Parish Police Jury place a ½ parish wide sales tax on the March 28, 2015 ballot.

At this time, President Scott Davidson presented and read aloud the proposed parish wide ½ sales tax proposition to be placed on the March 28, 2015 ballot.

President Davidson explained the Police Jury's Operating Procedure where a new tax proposal has to "rest" 30 days before formal action can be taken on said action by the Police Jury.

# **RESOLUTION 2014-020**

A resolution ordering and calling a special election to be held in the Parish of Claiborne, State of Louisiana, to dedicate the revenues derived from a special tax therein; making application to the State Bond Commission in connection therewith and providing for other matters in connection therewith.

**BE IT RESOLVED** by the Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Claiborne, State of Louisiana (the "Parish"), that:

SECTION 1. Election Call. Subject to the approval of the State Bond Commission, and under the authority conferred by Article VI, Section 29(B) of the Constitution of the State of Louisiana of 1974, the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the Parish on March 28, 2015, between the hours of seven o'clock (7:00) a.m., and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

#### **PROPOSITION**

Shall the Claiborne Parish Police Jury (the "Parish"), under the provisions of Article VI, Section 29 of the Constitution of the State of Louisiana of 1974, and other constitutional and statutory authority, be authorized to levy and collect, a tax of one-half of one percent (0.5%) (the "Tax") upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the Parish, all as defined by law, for a period of ten (10) years, commencing May 1, 2015 and ending May 1, 2025, the levy of the Tax for the first year is expected to collect approximately \$700,000, with the proceeds of the Tax (after paying costs of collecting and administering the Tax), to be transferred to the Claiborne Parish Hospital Service District No. 3 (the "District") pursuant to an Intergovernmental Agreement with the Parish and dedicated for the purpose of the District's operation, maintenance and improvement of hospital facilities and equipment for the Claiborne Memorial Medical Center (formerly known as the Homer Memorial Hospital)?

**SECTION 2.** Publication of Notice of Election. A Notice of Special Election shall be published in *The Haynesville News*, a newspaper of general circulation within the Parish, published in Homer, Louisiana, and being the official journal of the Governing Authority, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for the election, which Notice shall be substantially in the form attached hereto as **Exhibit A** and incorporated herein by reference the same as if it were set forth herein in full.

SECTION 3. <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Police Jury Room of the Police Jury Complex Administrative Building, Homer, Louisiana, on WEDNESDAY, APRIL 8, 2015, NINE O'CLOCK (10:00) A.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the results of the said election.

**SECTION 4.** <u>Polling Places</u>. The polling places set forth in the aforesaid Notice of Special Election are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

**SECTION 5.** <u>Election Commissioners</u>; <u>Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to <u>Section 4</u> hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held on Wednesday, April 8, 2015, as provided in

<u>Section 3</u> hereof. All registered voters in the Parish are entitled to vote at said special election and voting machines shall be used.

**SECTION 6.** <u>Authorization of Officers</u>. The Secretary-Treasurer of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the President and/or Secretary-Treasurer of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election, including but not limited to, appropriate submission to he Federal Department of Justice under Section 5 of the Federal Voting Rights Act of 1965, as amended.

**SECTION 7.** Furnishing Election Call to Election Officials. Certified copies of this Resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines in and for the Parish of Claiborne, State of Louisiana, and the Registrar of Voters in and for said Parish, as notification of the special election herein called in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. Employment of Counsel. It is recognized, found and determined that a real necessity exists for the employment of Legal Counsel in connection with the election; accordingly, Breithaupt, Dunn, DuBos, Shafto & Wolleson, LLC, Monroe, Louisiana, is hereby employed as legal counsel to perform comprehensive, legal and coordinate professional work with respect to the election. Counsel shall (i) prepare and submit to the Governing Authority for adoption all proceedings incidental to the election; (ii) advise the Governing Authority with respect to the election; and (iii) in the event said election carries, to serve as Bond Counsel in connection with the funding of proceeds of the Tax into Bonds. The fee to be paid Bond Counsel shall be an amount not greater than the Attorney General's then current Bond Counsel Fee Schedule and other guidelines for comprehensive, legal and coordinate professional work, together with reimbursement of out-of-pocket expenses incurred and advanced in connection with the election, said fee to be payable by the Governing Authority subject to the Attorney General's written approval of said employment and fee.

**SECTION 9.** <u>Application to State Bond Commission</u>. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event that election carries for further consent and authority to dedicate the proceeds of the tax, and a certified copy of this Resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.

**SECTION 10.** This Resolution shall become effective only upon the Governing Authority's final adoption in accordance with its policies and procedures concerning election call resolutions.
