The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 9<sup>th</sup> day of August 2017. On being called to order by President Scott Davidson, the following Jurors were present:
