#### **MINUTES**

Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. March 6, 2024 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on Wednesday the 6th of March 2024. On being called to order by President, Scott Davidson, the following Jurors were present:

There were 25 others in attendance which included, Secretary-Treasurer Dwayne R. There was a Road Committee Meeting held at 9:00 am in the Police Jury Conference Room.

President Scott Davidson called the meeting to order.

The meeting was opened with a word of Prayer led by Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Joseph Merritt, duly seconded by Kevin Gray, the Jury unanimously approved the following consent agenda:

# **Consent Agenda**

- 1. Approval of the February 7, 2024, regular meeting minutes as published in the Official Journal.
- 2. Payment of the February 2024 bills as approved by the Claims Committee.
- 3. Request from Town of Haynesville, in a letter received February 22, 2024, requesting (1) one load of SB2, (1) one load of cold mix, and (1) load of red clay mix to be delivered to the Town's city shop located on Spring Street. The work will be down under the Town's ad valorem tax credit.
- 4. Request from the Village of Athens, in a letter received February 26, 2024, requesting assistance from the CPPJ Hwy Dept. in cutting a dead tree located on Liles Road. The work will be done under the Village's ad valorem tax credit.
- 5. Request from the Homer Golf Club, in a letter received February 28, 2024, requesting assistance from the CPPJ Hwy Dept. with certain maintenance issues on their road. The work will be done on a reimbursement basis.

At this time, President Scott Davidson updated everyone on the recent visit to Claiborne Parish from the US Speaker of the House, the Honorable Mike Johnson. President Davidson stated that the Jury was humbled to be invited and to host to a meeting for Speaker of the House Johnson who invited other parish community leaders for an update on the challenges that we are facing in Washington. President Scott Davidson was pleased to see that Speaker of the House Mike Johnson still found the time to meet with leaders of the surrounding communities to listen to their concerns and needs. To our knowledge, this was the first US Speaker of the House to visit Claiborne Parish.

### Regular Agenda

President Scott Davidson read aloud a notice that all Parish Employees are required to complete one (1) hour of ethics training by December 31, 2024.

President Scott Davidson reminded everyone that one (1) hour of Preventing Sexual Harassment Training is required to be completed by December 31, 2024, by all Parish Employees – Department Heads and Jury Members have a two (2) hour training requirement.

President Scott Davidson reminded all Jurors that their personal financial disclosure statements for 2023are due by May 15, 2024.

President Scott Davidson read aloud a notice that there will be small premium increase for the Police Jury's Dental Plan with DINA Dental for the 2024-2025 fiscal year, effective June 1, 2024. The cost will be as follows per month - employee Only \$33.06, plus spouse \$65.00, plus child(ren) \$71.54 and plus family \$107.20. This elective coverage and the employee bears 100% of the cost.

President Scott Davidson read aloud a notice that there will be NO premium increases for the Police Jury's Vision Plan with CEC Vision for the 2024-2025 year. The cost will be as follows per month - employee only \$10.19, plus spouse \$20.37, plus child(ren) \$21.39, and plus family \$30.56. This is elective coverage and the employee pears 100% of the cost.

President Scott Davidson read aloud a notice that 2024-2025 Claiborne Parish Population Estimate as of submitted by the LSU AgCenter Department of Agricultural Economics and Agribusiness, Dr. Troy C. Blanchard from the LSU Department of Sociology is 13,526. (Prior year was 13,681 - a decrease of 155 or -1.13%).

At this time, President Scott Davidson recognized Truck Driver Mike Ellis who retired from the CPPJ Hwy Dept on January 19, 2024. Mr. Ellis worked for the Hwy Department on two separate occasions 2006-2008 and 2015-2024. President Scott Davidson and the Jurors presented Mike Ellis with a jacket for his years of service to the Parish.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously adopted Resolution 2024-009 – A Resolution Authorizing the President and Secretary-Treasurer to Sign Documents on Behalf of the CPPJ Concerning the Donation of Parcel No. 8730000655 Located on East Second Street to the Town of Homer.

Upon motion by Gil Dowies, duly seconded by Joseph Merritt, the Jury unanimously voted to renew the lease with DART for use of office space in the CPPJ-OOCS Building located at 621 South Main St., Homer, LA in the amount of \$350 per month. (same as 2023)

Upon motion by Mary McDaniel, duly seconded by Rev. Willie Young, Sr., the request from Secretary-Treasurer Dwayne R. Woodard to enter into a Memorandum of Agreement with the Louisiana Military Department, Office of Cyber Security which will enable GOHSEP to perform a Cyber Readiness Assessment of the CPPJ Systems. This is a free service offered to the Parish through GOHSEP.

At this time President Scott Davidson presented the items from the Road Committee.

Upon motion by Gil Dowies, duly seconded by Paul Cook, the Jury unanimously approved upon recommendation from the Road Committee to hire Mr. Toby Page as a full-time Mechanic Helper effective 3/14/2024 at rate of \$12.50 per hour with benefits. (Mr. Page has been working for the Jury through Man-Power for the past two months)

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved, upon recommendation from the Road Committee, to declare surplus the 1994 Mack Dump Truck VIN ending in and to list the vehicle for auction on GOVDEALS.COM.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved, upon recommendation from the Road Committee, to declare surplus the 2000 Mack Dump Truck VIN ending, but to keep the truck in service until the new dump truck arrives. At that time a decision will be made on how to list the truck for disposition (placed on GOVDEALS.COM, Mt. Olive Auction or have advertised in the paper for bid).

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved to fence in and install cameras at the roll-off dumpsters located at the Old Road Barn at 4070 Hwy 79 in Homer. The dumpsters will be fenced off from the rest of the property, which will allow the equipment storage area to be secured and locked. Signage will also be posted warning individuals of a possible fine of \$500 fine for illegal dumping.

At this time, Claiborne Parish Coroner Dr. Mark Haynes, gave his monthly Coroner's report there were 19 deaths for the month of February in the Parish - (12) Hospice/ER, (2) CMMC, (1) other, (2) on scene with no autopsy, and (2) that required autopsies. His office had (2) CECs for the month.

Dr. Mark Haynes gave his update on the clinics and CMMC for the month of February. There has been an uptick of COVID with mild-moderate symptoms. Occasionally there will be an admit to the hospital for COVID with other health related issues. They are still seeing the flu sporadically in the clinics and at the hospital.

# **Additional Public Comments:**

District 4 DOTD Director David North instructed the Police Jury to keep its equipment off State of Louisiana Highways during icy conditions. District Two Juror Mark Furlow explained the situation from the Jury's standpoint and that 3 days after the event there was still over and inch of solid ice on all roads, but State and Parish and it presented a public safety factor for EMS and law enforcement vehicles. President Davidson reiterated the fact that in extreme events the Jury would do what was necessary to ensure the public safety. After a very heated discussion between Mr. North and District 2 Juror Mark Furlow, District 10 Juror Rev. Willie Young, Sr.

recommended that the Jury obtain advice on this issue from the District Attorney and our State Representative and Senator, along with the Governor's Office so that we can help serve and protect the citizens of Claiborne Parish during a severe winter storm emergency. (They welcome our help during times of tornados, windstorms and flooding to help clear and open statemaintained highways.)

Rev. Willie Young, Sr. thanked Secretary Treasurer Dwayne Woodard for setting up the meeting with Speaker of the House Mike Johnson. Rev. Young stated that the Speaker has done a great job representing this area and he wanted to thank him for coming.

DART Director Cynthia Johnson asked the Jurors for help find meeting places for her to reach further into the rural areas of the Parish. President Scott Davidson told her to get with each community center to see if they would be available.
