The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 4th of December 2019. On being called to order by President Scott Davidson, the following Jurors were present:

Mark Furlow, Kevin Gray, Paul Cook, Joseph Merritt, Jr., Tommy Sanders, Gil Dowies, and Rev. Willie Young.

District One Juror James Laird and District Four Juror A.D. Williams were absent.

Nine (9) others in attendance which included, Secretary-Treasurer Dwayne R. Woodard, Parish Road Superintendent Tommy Durrett, Claiborne Parish Sheriff Ken Bailey, Claiborne Parish Coroner Dr. Mark Haynes, OOCS Director Tim Cain, Mr. Sam Dowies of the Claiborne Parish Watershed District, Mrs. Tina Haynes (Interim CEO), Ms. Angie Constelis, and Mrs. Kristi Copeland (DON) all of CMMC.

The meeting was opened with a word of Prayer led by Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Joe Merritt, duly seconded by Paul Cook, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved to amend the agenda and add the following items:

RESOLUTION 2019-027

A resolution providing for canvassing the returns and declaring the result of the special election held in the Parish of Claiborne, State of Louisiana, on Saturday, November 16, 2019, to authorize the levy of a sales and use tax therein.

BE IT RESOLVED by the Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Claiborne, State of Louisiana, that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of Claiborne, State of Louisiana, on SATURDAY, NOVEMBER 16, 2019, to authorize the levy of a sales and use tax therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. <u>Procès Verbal.</u> A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Claiborne, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. <u>Promulgation of Election Result.</u> The result of said election shall be promulgated by publication in the manner provided by law.

Main Street, Homer, Louisiana, the Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Claiborne, State of Louisiana (the "Parish"), and being the authority ordering the special election held therein on Saturday, November 16, 2019, with the following members present:

Mark Furlow, Kevin Gray, Paul R Cook, Scott Davidson, Joseph Merritt Jr, Tommy Sanders Gil Dowies and Rev. Willie J Young Sr.;

There being absent: James Laird and A D Williams;

did, in open and public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to wit:

PROPOSITION (SALES & USE TAX RENEWAL)

Shall the Parish of Claiborne, State of Louisiana (the "Parish"), under the provisions of law, be authorized to levy and collect a tax of one-eighth of one percent (1/8%) (the "Tax") (an estimated \$156,000 reasonably expected to be collected annually from levy of the Tax) upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the Parish for a period of seven (7) years, commencing January 1, 2021, with the avails or proceeds of the Tax (after paying reasonable and necessary costs of collecting and administering the Tax), to be dedicated to the conservation and development of natural resources for agricultural, commercial, residential or other purposes, including surface and ground water, promoting safety on lakes and waterways, both within and without the Parish, and including equipment and improvements necessary for the above purposes, to be administered by the Claiborne Parish Watershed District pursuant to an intergovernmental agreement with the Parish?

There was found by said count and canvass that there was a total of **2,915** votes cast **IN FAVOR OF** the Proposition and a total of **2,013** votes cast **AGAINST** the Proposition, as hereinabove set forth, and it was further found and determined that there was a majority of **902** votes cast **IN FAVOR OF** the Proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Proposition as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the Parish on Saturday, November 16, 2019.

President Scott Davidson presented the Ordinance No. 787 – An Ordinance Adopting and Enacting a New Code for Claiborne Parish, Louisiana –

ORDINANCE NO. 787

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR CLAIBORNE PARISH, LOUISIANA; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE CLAIBORNE PARISH POLICE JURY:

<u>Section 1.</u> The Code entitled "Code of Ordinances, Claiborne Parish, Louisiana," published by Municipal Code Corporation, consisting of chapters 1 through 102, each inclusive, is adopted.

Section 2. All ordinances of a general and permanent nature enacted on or before January 11, 2017, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. Unless another penalty is expressly provided, every person convicted of a violation of any provision of the Code or any ordinance, rule or regulation adopted or issued in pursuance thereof shall be punished by a term of imprisonment of up to thirty (30) days in the parish jail or a fine of not exceeding five hundred dollars (\$500.00) or both. Each act of violation and each day upon which any such violation shall continue or occur shall constitute a separate offense. The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance. In addition to the penalty prescribed above, the Parish may pursue other remedies such as abatement of nuisances, injunctive relief and revocation of licenses or permits.

Section 5. Additions or amendments to the Code when passed in such form as to indicate the intention of the parish to make the same a part of the Code shall be deemed to be incorporated in the Code, so that reference to the Code includes the additions and amendments.

Section 6. Ordinances adopted after January 11, 2017, that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.

Section 7. This ordinance shall become effective

At this time, Dr. Mark Hayes gave an update of the year ending of the Coroner's Office. He told the Jury that the Coroner's Office has applied and been awarded a grant in the amount of \$20,667. for Technology Equipment to assist in investigation of deaths related to opium use. There were (9) deaths – (6) Hospice/ER (1) Autopsy (1) other facility (1) Investigated with no autopsy and (2) CECs.

Secretary-Treasurer Dwayne Woodard addressed the Jury of the future of our residential garbage pick-up. Sales Tax Fund has continued to drop over the past few years. Unless you are paying taxes on large ticket items, such as a car or tractor, or purchasing items from the few convenience stores located in the unincorporated areas of the Parish, you are not paying sales tax for your trash pick-up. In the next 5-10 years, the Jury will be looking at having to do something to cover cost of road side pick-up for each household in the Parish outside of the incorporated areas of Homer and Haynesville.

President Scott Davidson agreed with Mr. Woodard and said that we need to be thinking of how to pay for this or have ugly roadside dumpsters around the Parish. Either way, the 1% Parish Sales Tax cannot continue to support the growing cost of waste disposal.

Sheriff Ken Bailey told the Jurors that he was totally shocked that this last sales tax renewal almost failed and only passed by barely 200 votes. Who wouldn't want your trash picked up at your driveway at virtually no cost to the average household?
