MINUTES

Of the Regular Meeting of The Claiborne Parish Police Jury February 5, 2014 Homer, LA 71040

The Claiborne Parish Police Jury met in a legally convened regular session in the Jury Chambers of the Police Jury Complex, located at 507 West Main Street in Homer, LA at 9:00 a.m. on the fifth day of February 2014. On being called to order by Vice-President Jerry Adkins, the following jurors were present:

Upon motion by Rev. Willie Young, Sr., duly seconded by Roy Mardis, the Jury unanimously approved the request from Secretary-Treasurer Woodard to seek statements of qualifications for Architectural Services for Conceptual Drawing for the Proposed New CPSO Administrative Office and Women's Detention Facility. Statements will be due by 2:00 p.m. on Friday, March 14, 2014 and will be acted upon at the April 9, 2014 regular meeting.

Upon motion by Roy Mardis, duly seconded by Joe Sturges, the Jury unanimously approved the annual request for the Coordinating & Development Corporation for the Parish's annual dues for the year 2014 in the amount of \$8,725.

Upon motion by Mark Furlow, duly seconded by Joe Sturges, the Jury unanimously approved the request from Claiborne Parish Fire District #4, in a letter dated January 29, 2014, requesting the appointment of Marcus McClung to fill the vacancy on their board due to the resignation of Hardy Louviere.

Upon motion by Joe Sturges, duly seconded by Mark Furlow, the Jury unanimously appointed Stephanie A. Sanders of 2328 Park Drive, Haynesville, LA 71038 to fill the remainder of the unexpired term of Justice of the Peace in Wards 3,4, & 5 in Haynesville, LA. C.F. "Chuck" Clawson tendered his resignation as of February 1, 2014 due to he no longer resides in these wards.

Upon motion by Rev. Willie Young, Sr., duly seconded by Roy Mardis, the Jury unanimously approved, upon recommendation of the Personnel Committee, the hiring of Jimmy Smith as a Mechanic/Welder fulltime beginning February 13, 2014 with the starting pay of \$12.25 per hour. Mr. Smith will spend (2) two years in "Class A" due to his entry level of pay.

Lavelle Penix asked the Jury for a possibility of an ordinance dealing with noise pollution from stereos, audio devices or noise producing instruments. Upon much discussion between the Jury and Sheriff Ken Bailey as to what would be considered too loud and how you would patrol this issue, Roy Mardis made a motion to table this for the next meeting, with no second, this motion died due to a lack of a second. Lavelle Penix made a motion to form a committee to look into forming an ordinance on noise pollution, this motion also died due to a lack of a second.
