# PUBLIC HEARINGS

The Claiborne Parish Police Jury will conduct two (2) public hearings on Friday, August 4, 2023, beginning at 10:00 a.m. in the Police Jury's Conference Room, Homer, Louisiana.

The purpose of the first public hearing will be to receive comments on the Parish's performance on its FY 2021 Louisiana Community Development Block Grant (LCDBG) Program (Contract No. 2000620373) for water improvements. The Parish will submit close-out documents for the aforementioned LCDBG program to the Louisiana Division of Administration within fifteen (15) calendar days of this notice.

The second public hearing, a Fair Housing Informational hearing, will be conducted following the Performance Hearing. The purpose of this hearing is to discuss the fair housing policies, including the Fair Housing Act as Amended (Title 8), and any recommendations for improving the fair housing opportunities within the community.

All residents of the Parish, particularly low to moderate income persons, are invited to attend and submit comments.
