MINUTES

Of the Regular Meeting of The Claiborne Parish Police Jury June 8, 2016 Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Conference Room of the Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the eighth day of June 2016. On being called to order by President Scott Davidson, the following Jurors were present:

Kevin Gray, Joe Sturges, Paul Cook, Joseph Merritt, Jr., Tommy Sanders, and Rev. Willie Young, Sr.

Vice-President Mark Furlow and District Ten Juror Gil Dowies were absent.

The District One Juror's seat was vacant due to the resignation of Mr. D'Arcy Stevens on May 31, 2016.

Upon motion by Tommy Sanders, duly seconded by Joe Sturges, the Jury unanimously approved, Upon Recommendation from the Grants Committee, the following CWEF Grant applications will be submitted June 9, 2016 - South Claiborne Water System in the amount of \$50,000 for new pumps for Liles substation which will help approximately 400 homes and the Lisbon Water System in the amount of \$50,000 for replacing 5,525 ft. of 1 ½ inch water line to 3 inch along Hwy 2 West which serves approximately 40 homes. Secretary-Treasurer Woodard stated the other 2 applications from Summerfield Water System and Leatherman Creek Water System will be added on the LGAP application this next cycle since these were not dealing with improvements to quality or quantity of delivery of water by the water systems.

A RESOLUTION OF SUPPORT FOR THE FY 2015-2016 COMMUNITY WATER ENRICHMENT FUND GRANT DUE JUNE 9, 2016

WHEREAS, the FY 2015-2016 Community Water Enrichment Fund provides financial assistance to the local units of government in rural areas for the sole purpose of improving or rehabilitating water systems;

WHEREAS, the FY 2015-2016 Community Water Enrichment Fund Grant will be administered by the Office of Community Development (OCD); and

WHEREAS, the grant application and guidelines require a resolution of support from the local governing authority; and

WHEREAS, the Claiborne Parish Police Jury is applying for up to \$100,000 of FY 2015-2016 Community Water Enrichment Fund grant monies at the parish level; and

WHEREAS, the Claiborne Parish Police Jury intends to use these grant monies on up to possibly (2) two projects for the Claiborne Parish Police Jury (1) \$50,000 for the South Claiborne Water System for the installation of new pumps and a variable drive system at the Liles Booster Station which will help 400 homes and (2) \$50,000 for the Lisbon Water System to replace 5,525 feet of existing 1 ½ inch line with 3 inch line along Hwy 2 west of the main well; and

WHEREAS, the Claiborne Parish Police Jury will be providing local funds up to \$10,000 to ensure completion of the awarded projects;

BE IT RESOLVED, that the Claiborne Parish Police Jury does hereby approve and support this grant application and its purpose.

A PROCLAMATION ORDERING AN ELECTION FOR POLICE JUROR, DISTRICT 1, FOR THE REMAINDER OF THE UNEXPIRED TERM AND OTHERWISE PROVIDE WITH RESPECT THERETO.

BE IT PROCLAIMED by the Police Jury, Parish of Claiborne, State of Louisiana:

- Section 1: A vacancy for Police Juror, District 1, Parish of Claiborne, State of Louisiana, exists due to the resignation (due to health reasons) of D'Arcy Stevens, prior to the end of his term, ending January 12, 2020.
- Section 2: An election is hereby called and proclaimed to fill the vacancy for Police Juror, District 1, Parish of Claiborne, State of Louisiana, said election to be held as follows:
 - A) Qualification for the election shall be July 20, 2016, July 21, 2016 and July 22, 2016;
 - B) The primary election to fill the vacancy for Police Juror, District 1, Parish of Claiborne, State of Louisiana shall be held on November 8, 2016;
 - C) The general election to fill the vacancy for Police Juror, District 1, Parish of Claiborne, State of Louisiana shall be held on December 10, 2016.
- Section 3: That certified copies of this proclamation shall be forwarded to the Secretary of State, the Commissioner of Elections, the Clerk of Court, and Ex-Officio Parish Custodian of voting machines and the Registrar of Voters in and for the Parish of Claiborne, as notification of the election herein called in order that each may prepare for said election and perform their respective functions as required by law.
