The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 11th of July. On being called to order by President, Scott Davidson, the following Jurors were present:

WHEREAS, the Claiborne Parish Police Jury makes no promises to chip, seal or pave the above-mentioned roads in the immediate future;

BE IT HEREBY RESOLVED that the Claiborne Parish Police Jury accepts Bell Buoy Road (Parish Road No. 510) and Bell Point Road (Parish Road No. 511) into the Claiborne Parish Road System for public use effective August 1, 2018.

President Scott Davidson read aloud a notice: as of July 1, 2018- The Haynesville News will be the Official Journal of the Claiborne Parish Police Jury for the period of July 1, 2018 to June 30, 2019 as per the rotation schedule adopted by the Claiborne Parish Police Jury on June 4, 2014.

President Scott Davidson read aloud a notice: Notice is hereby given that the Claiborne Parish Police Jury will ADOPT the 2018 ad valorem tax millages for all funds on Wednesday, September 12, 2018, at 10L00 am at the Claiborne Parish Police Jury Administration Building in the Jury Chambers, located at 507 West Main St., Homer, LA 71040.

President Scott Davidson read aloud a notice: The employer contribution rate for the District Attorneys' Retirement System will increase to 1.25% for the fiscal year beginning July 2018. (contribution rate was 0.0% for the period July 1, 2017 to June 30, 2018)

President Scott Davidson read aloud a notice: The Employer contribution rate for the Registrar of Voters Employees Retirement System will remain at 17.0% for the fiscal year beginning July 1, 2018.

President Scott Davidson read aloud a notice: The Employer contribution Rate for the Parochial Employee's Retirement System will remain at 11.50% for the year beginning January 1, 2019.

Upon motion by Paul Cook, duly seconded by Joe Sturges, the Jury unanimously approved the acceptance of the Annual Precinct Survey, dated July 3, 2018, as required by LA R.S. 18:532B concerning precincts that have less than 300 registered voters.

Upon motion by Mark Furlow, duly seconded by James Larid, the Jury unanimously adopted a years of service bonus structure for the CPPJ hourly office administration employees. District Eight Juror Tommy Sanders recused himself from voting.

Upon motion by Gil Dowies, duly seconded by Paul Cook, the Jury unanimously approved the request from Secretary-Treasurer, Dwayne Woodard, for an hourly base wage increase of \$0.25 per hour for both the Assistant Secretary-Treasurer Shelia W. Washington and Administrative Clerk Leigh Ann Sanders, based on their employee evaluations. (new hourly base rate will be \$15.25 per hour). District Eight Juror Tommy Sanders recused himself from voting.

The replacement of the (20 two Claiborne Parish Watershed District members which are rotating off in September 2018 has been tabled until the August 2018 Regular Jury Meeting to give jurors time to look over the 4 letters of interest received from the Watershed District for filling these positions.

Juror Mark Furlow asked Road Superintendent to update the public on Winn Bottom Rd and Bellew Rd. which were recently damaged from a road closure by the state on Alt. 2. Road Superintendent Durrett told the Jury that he had requested help from the state due to the amount of time and the traffic that was re-routed to these two roadways. According to Road Superintendent Tommy Durrett, the State has no funding to help with these repairs, so it will be up to the Parish to repair them. He told the Jury the Road Crew would have to go back in and repair damage to the base, which will take a little time to repair.

At this time, Parish Coroner, Dr. Mark Haynes, gave his monthly report from the Coroner's Office: There were 8 deaths (4) ER/Hospice, (2) Autopsies, (1) On Scene, and (1) CEC.
