#### **MINUTES**

Of the Regular Meeting of The Claiborne Parish Police Jury July 8, 2015 Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the eighth day of July 2015. On being called to order by Vice-President, Jerry Adkins, the following jurors were present:

D'arcy Stevens, Mark Furlow, Robert "Bob" McDaniel, Joe Sturges, Roy Mardis, and Rev. Willie Young, Sr. (late arrival).

President Scott Davidson, Lavelle Penix and George Tigner, III were absent.

There were 13 others in attendance which included, Secretary-Treasurer Dwayne R. Woodard, Road Superintendent Tommy Durrett, Sheriff Ken Bailey, Mrs. Jodie Heigle of OOCS, Mrs. Cathy Greeson of OEP, Mrs. Pam Suggs of the Claiborne Parish Library, Mr. Lee Faulk and Teresa Raley of the Claiborne Parish 4-H, Mayor Roy Lewis of Homer, Ms. Jackie Roberts of the Haynesville News, Rev. Terry Willis of Homer, Mr. Joey White of Claiborne Electric, and Mr. Donald Malray of Homer.

The meeting was opened with a word of Prayer led by Roy Mardis, followed by the Pledge of Allegiance led by Mayor Roy Lewis.

Upon motion by Roy Mardis, duly seconded by Mark Furlow, the Jury unanimously voted to adopt the Regular agenda as presented.

Upon motion by Joe Sturges, duly seconded by Robert McDaniel, the Jury unanimously voted to amend the agenda and add the following:

1. Request from Town of Homer Public Works Director, Lee Wells for one (1) load of Cold Mix and twenty-five (25) stop signs (24" x 24") to be done on a reimbursement basis with their ad valorem tax credit.

Upon motion by Roy Mardis, duly seconded by Joe Sturges, the Jury unanimously approved the consent agenda as follows:

- 1. Approval of the June 10, 2015 regular meeting minutes.
- 2. Payment of the June 2015 bills as approved by the Claims Committee.
- 3. Request from Main Street Homer, in an email received on June 30, 2015, requesting the use of the Court House Lawn for the 2<sup>nd</sup> Annual Great Louisiana Harmonica Festival.
- 4. Request from the Sparta Groundwater Commission, in a letter received June 16, 2015, requesting their annual budgeted contribution of \$3,000 and to be included in the Parish's 2016 operating budget. This money is used for the commission's operating budget. This money is used for the commission's operations and education programs concerning the Sparta Aquifer. (same as prior years)
- 5. Request from the Claiborne Parish 4-H Outdoor Skills Program, in a letter dated June 17, 2015, requesting \$277.81 from the Police Jury to help pay the cost of decaling the new Shooting Sports Trailer.

## Regular Agenda

Vice-President Adkins read aloud a thank you note from Mrs. Erin White thanking the Police Jury for their help with the reception honoring Dr. Donald K. Haynes.

Vice-President Adkins read aloud a notice, the Claiborne Parish Police Jury will sit as a Board of Review for the 2015 Toll for a 15 day period beginning on September 9, 2015 and ending on September 23, 2015. The hearing date for the Board of Review will be on Wednesday, September 16, 2015 at 10:00 a.m. in the Jury Room of the CPPJ Administrative Building located at 507 West Main Street in Homer, LA 71040.

Vice-President Adkins read aloud a notice, the Employer Contribution Rate for the District Attorney's Retirement System, will drop to 3.50% for the fiscal year beginning July 1, 2015. (Contribution rate was 7.0% for the period July 1, 2015 to June 30, 2015)

Upon motion by Roy Mardis, duly seconded by Joe Sturges, the Jury unanimously approved the request from Sparta Commission to reappoint Dwayne R. Woodard to the Commission for a (4) four year term beginning October 16, 2015.

Upon motion by Roy Mardis, duly seconded by Joe Sturges, the Jury unanimously approved, upon recommendation from the Personnel Committee, the hiring of Mr. Tim Cain for the OOCS Director position beginning August 3, 2015 with a beginning annual salary of \$35,000 plus benefits.

Vice-President Adkins read a notice; the Police Jury's 2014 Audited Financial Statements will be presented at the August 5, 2015 regular meeting due to Melissa Bosch having jury duty today.

Upon motion by Joe Sturges, duly seconded by Robert McDaniel, the Jury unanimously approved the request from Town of Homer Mayor Roy Lewis to appoint Tammy Sampson to the board of Claiborne Parish Hospital Service District No. 3, in a letter received July 1, 2015, to fill the unexpired term of former Commissioner Alecia N. Smith who was removed due to excessive absences as per the District's by-laws.
