MINUTES Of the Regular Meeting of The Claiborne Parish Police Jury September 14, 2016 Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the Fourteenth day of September, 2016. On being called to order by President, Scott Davidson, the following jurors were present:

Patricia Stevens, Kevin Gray, Joe Sturges, Paul Cook, Joseph Merritt, Jr., Tommy Sanders, Gill Dowies, and Rev. Willie Young, Sr.

District Two Juror Mark Furlow was absent due to the death of his mother.

There were 15 others in attendance which included, Secretary-Treasurer Dwayne R. Woodard, Sheriff Ken Bailey, Tax Assessor Bob Robinson, Mr. Tim Cain of OOCS, Mrs. Pam Suggs of the Claiborne Parish Library, Town of Homer Mayor Roy Lewis, Mr. Lee Faulk of the Claiborne Parish 4-H, Ms. Jackie Roberts of the Haynesville News, Claiborne Parish Coroner Dr. Mark Haynes, South Road Foreman Joe Buggs, North Road Foreman Chad Verdin, Mr.& Mrs. Jimmy White and Ms. Brandi White.

The meeting was opened with a word of Prayer led by Rev. Willie Young, Sr., followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Joseph Merritt, Jr., duly seconded by Kevin Gray, the Jury unanimously voted to adopt the Regular agenda as presented.

Upon motion by Joe Sturges, duly seconded by Patricia Stevens, the Jury unanimously voted to amend the agenda and add the following:

Regular Agenda

At this time, President Scott Davidson recognized the retirement of Operator I Jimmy White for his 30+ years of service to the Claiborne Parish Highway Department.

Upon motion by Paul Cook duly seconded by Joseph Merritt, Jr., the Jury unanimously voted to leave the Regular Police Jury meeting and enter into the Public Hearing for the 2016 Board of Review.

President Scott Davidson presented the 2016 millage totals for the Parish which was \$143,740,253 in assessed value which was a slight decrease from the \$144,656,404 from 2015 but it should project to be about a 1% increase in Ad Valorem Tax collected for the 2016 year.

President Scott Davidson asked twice if there were any Public Comments of request to appeal to the Board of Review. Secretary-Treasurer informed the Board that no formal comments had been received whether written or oral.

Upon motion by Joe Sturges, duly seconded by Mrs. Patricia Stevens, the Jury unanimously approved the assessment of property values for the 2016 Property Rolls.

President Davidson called for any additional public comments concerning the Assessed Values of the 2016 property roll. There were none.

Upon motion by Kevin Gray, duly seconded by Joe Sturges, the Jury voted to leave the Public Hearing for the 2016 Board of Review and return to the regular meeting for the Police Jury.

Upon motion by Tommy Sanders, duly seconded by Kevin Gray, by roll call vote, with (9) being for, (0) being against, and (1) being absent, the Jury approved Resolution 2016 - 013 - A Resolution Levying Millages for the 2016 Tax Roll for the Claiborne Parish Police Jury.

A resolution ordering and calling a special election to be held in Claiborne Parish Sales Tax District, to authorize the levy of a sales and use tax therein; making application to the State Bond Commission in connection therewith; and providing for other matters in connection therewith.

BE IT RESOLVED by the Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of Claiborne Parish Sales Tax District (the "District"), that:

SECTION 1. <u>Election Call</u>. Subject to the approval of the State Bond Commission, and under the authority conferred by Article VI, Section 29 of the Constitution of the State of Louisiana of 1974, the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the District on **SATURDAY, DECEMBER 10, 2016**, between the hours of seven o'clock (7:00) a.m., and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (SALES TAX)

Shall Claiborne Parish Sales Tax District (consisting of the entire Parish of Claiborne except those portions of the Parish contained within the corporate boundaries of the municipalities of Homer or Haynesville) (the "District"), under the provisions of Louisiana law, be authorized to levy and collect a tax of one percent (1%) (the "Tax") (an estimated \$630,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year) upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the District, all as defined by law, for a period of ten (10) years from January 1, 2017, with the proceeds of the Tax (after paying the expenses of collecting and administering the Tax) to be dedicated and used for the purposes of paying the costs of (i) providing for solid waste collection and disposal in the District, including acquiring, improving, maintaining and/or operating the necessary land, facilities and equipment required in connection therewith, and (ii) materials required for surfacing and maintaining public roads within the boundaries of the District?

SECTION 2. <u>Publication of Notice of Election</u>. A Notice of Special Election shall be published in the *Haynesville News*, a newspaper of general circulation within the District, published in Homer, Louisiana, and being the official journal of the District, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

SECTION 3. <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Jury Chambers of the Police Jury Complex, 507 West Main Street, Homer, Louisiana, on **WEDNESDAY, DECEMBER 14, 2016**, at **TEN O'CLOCK (10:00) A.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4. <u>Polling Places</u>. The polling places set forth in the aforesaid Notice of Special Election are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. <u>Election Commissioners; Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held on Wednesday, December 14, 2016, as provided in Section 3 hereof. All registered voters in the District will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. <u>Authorization of Officers</u>. The Secretary-Treasurer of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the President and/or Secretary-Treasurer of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election.

SECTION 7. <u>Furnishing Election Call to Election Officials</u>. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of Claiborne Parish and the Registrar of Voters of Claiborne Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. <u>Application to State Bond Commission</u>. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event said election carries for further consent and authority to levy and collect the sales and use tax provided for therein. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application. SECTION 9. <u>Additional Notice Requirement.</u> This Governing Authority made the announcement with respect to the adoption of this resolution required by La. R.S. 42:19.1, at its public meeting on Wednesday, August 10, 2016 and published said announcement in the Official Journal on Thursday, August 11, 2016.
