CPPJ Admin Bldg – 507 West Main Street, Homer LA 71040

1. Scarf existing foam roof and remove approximately 1 inch of old foam and dispose of
2. Install approximately 1 1/2 inch of new foam to roof, foam will slope to drains
3. 2 coats of silicone at 15 mills each with granules in last pass of coating
4. Provide 2-year workmanship warranty
5. Owner will be supplied with a year warranty from Green Shield Products (or equivalent)
6. Portion of roof has solar panel installation which must but not be damaged and this area must be done by hand

CPPJ Highway Dept – 24579 Hwy 2, Homer LA (admin area)

1. Scarf existing foam roof and remove approximately 1 inch of old foam and dispose of
2. Install approximately 1 1/2 inch of new foam to roof, foam will slope to drains
3. 2 coats of silicone at 15 mills each with granules in last pass of coating
4. Provide 2-year workmanship warranty
5. Owner will be supplied with a year warranty from Green Shield Products (or equivalent)

CPPJ Highway Dept – 24579 Hwy 2, Homer LA (metal roof area)

1. Power wash existing metal roof and make any repairs needed to existing foam on metal roof
2. Coat roof with 30 mills of silicone at 15 mills each pass with granules in last pass of coating
3. Provide 2-year workmanship warranty
4. Owner will be supplied with a year warranty from Green Shield Products (or equivalent)
